

A Survey On Fault Attacks On Symmetric Key Cryptosystems

Fault attacks are among the well-studied topics in the area of cryptography. These attacks constitute a powerful tool to recover the secret key used in the encryption process. Fault attacks work by forcing a device to work under non-ideal environmental conditions (such as high temperature) or external disturbances (such as glitch in the power supply) while performing a cryptographic operation. The recent trend shows that the amount of research in this direction; which ranges from attacking a particular primitive, proposing a fault countermeasure, to attacking countermeasures; has grown up substantially and going to stay as an active research interest for a foreseeable future. Hence, it becomes apparent to have a comprehensive yet compact study of the (major) works. This work, which covers a wide spectrum in the present day research on fault attacks that fall under the purview of the symmetric key cryptography, aims at fulfilling the absence of an up-to-date survey. We present mostly all aspects of the topic in a way which is not only understandable for a non-expert reader, but also helpful for an expert as a reference.

1 INTRODUCTION

With the emergence of the Internet of things and edge computing in modern era, small scale devices are becoming more ubiquitous. These devices often perform cryptographic operations, which are vulnerable to device-specific attacks. One such attack, referred to as *Fault Attack*¹ (FA)

is shown to be powerful against common ciphers; including the high-profile ones, which are considered secure against classical cryptanalysis methods. This concept was first presented to the cryptographic community in the context of public key cryptography, and adopted to symmetric key soon afterwards. In this type of attack, the attacker/adversary, Eve, is assumed to have physical access to the device under operation. She deliberately injects disturbances into the device while it is running some cryptographic computation. The disturbances could be injected by means of, for example, voltage glitches, Light Amplification by Stimulated Emission of Radiation (LASER) shots, sudden temperature variations. By utilizing the information from the correct (*non-faulty*) and the incorrect (*faulty*) outputs, she is normally able to deduce some information on the secret key. Under certain models, attacker does not need the non-faulty output, as the faulty output only is enough for her to recover the secret information.

On the device, a fault injected can modify/skip the normal flow of operation, alter/erase data, access non-permitted location of memory, perform a non-permitted operation, bypass certain countermeasures and so on. Basically, fault attacks allow the adversary to bypass certain security claims in contrary to classical cryptanalysis methods where the cipher is considered to be a black-box and therefore, it cannot be tampered with. As the recent research trend shows, FA is a very popular cryptanalysis technique in the community; thanks to its wide usability, practicality (often possible by a non-expert with cheap equipment), easy computations and the attacker's ability to simulate.

To keep track of the recent developments as well as to explore interesting open problems; few works put together various aspects of fault attacks, such as [20, 21, 81, 100]. However, as one may notice, there has not been a comprehensive survey in the recent years. For example, the fault attack automation frameworks (Section 6) are not mentioned in any of the earlier works. In general, it should be useful to the community to have a concise report on the more recent advancements. Furthermore, we attempt to provide new insights on the existing works (that can be used to break existing designs, such as the *precise bit flip* model in Section 2.1), interesting research directions that can be pursued in the future (such as, inherent DFA resistance in stream ciphers, see Section 5.1.1) and so on; at the same time streamlining the (somewhat confusing) terminologies.

We restrict ourselves to the fault attacks on the gray-box model in symmetric key cryptography. As such, fault attacks in post quantum cryptography, public key cryptography, theoretical cryptography (such as non-malleable codes) as well as white-box² are not considered within the scope.

The current survey provides a consolidated overview of existing research works that are reported in recent time. However, it is not limited to being an aggregation of results aimed at providing a bird's eye-view of the research area. It also provides a comprehensive outlook on future directions of research that follow from the discussions furnished. Many of the directions suggested have the potential of becoming viable in future and hence all of them are worthy of individual in-depth attention and investigation.

2 FAULT MODELS

By a fault model we mean the nature, efficiency, repeatability and feasibility of the faults injected. Nature of a fault can be described by the impact on the target device (such as, bits or a nibble/byte/word) and precision of location (targets one particular bit, etc.). Efficiency indicates attacker's precision (how precisely she can choose) the fault value. Repeatability means whether the attacker can repeat the identical fault (the fault value may be unknown) in either the temporal

or the spatial domain. Feasibility refers to the practical aspects (cost, equipment, time, expertise required) of the fault attack. Generally, it is accepted that a more restrictive/precise model is more difficult/impractical in the real life scenario.

2.1 Precise Bit Flip

The proponents of fault attacks try to show the effectiveness of their attacks by assuming as little as possible (e.g., the fault location is assumed to be unknown, which is later recovered through rigorous analysis). In terms of *Differential Fault Attack* (DFA, see Section 5.1.1), the strongest model would be to flip one particular bit (the round of the cipher as well as the location of the bit is chosen by the attacker). Such model, to the best of our knowledge, is never considered. Consider the effect of changing one input bit of an AND operation: $y = x_0 \wedge x_1$. If, say, Eve is able to precisely flip x_0 , then by judging whether the output changes or not, she is able to retrieve x_1 (no change in output means $x_1 = 0$, otherwise $x_1 = 1$). This way, any AND gate can be targeted. It is also interesting to notice, this model (which we call as, *Precise Bit Flip*), if/when exists, we break certain countermeasures in their current forms; such as the *Detection* (Section 7.2) or *Infection* (Section 7.3). Even though the cipher is ‘protected’ by detection or infection (which effectively stops her to get the faulty output she desires, see Section 7); the attacker is able to check whether flipping one bit of an AND operation changes the output (whether the output is suppressed in case of detection; or, a random value, instead of the non-faulty output, is returned in case of infection) or not. One way to protect against this model in such countermeasures would be to ensure that there is no non-linear operation that takes two bits as inputs; this can be done, e.g., implementing all the SBoxes as look-up tables.

2.2 Single/Multiple Fault Adversary

Majority of published works in fault attacks assumes *single fault adversary* model. Under this model, the attacker, Eve can inject faults at most once during one execution of the cipher (that may result in affecting multiple locations). So, if she injects two sets of faults, say, at the first & the last round of encryption, that will be considered a violation of the model. Relaxed model, where attacker can inject multiple sets of faults during one execution, has been proposed in rare cases, such as *Internal Differential Fault Analysis* (InDFA, see Section 5.2.2 for more details).

2.3 Random/Deterministic Fault Model

The random fault model is the one most commonly used in literature, e.g., [135, 166]. Here, the attacker can control in which round the faults can be injected; but cannot control the value changed by the fault injection. Basically, here the injected fault results in flipping one/more targeted bit(s) of the operand value(s). Generally, attacker can control the intensity, location and duration of the external disturbance, but cannot control the fault precision (the precise effect of fault is assumed to be unknown to her). Under certain cases, the exact fault location could also be assumed to be unknown (the attack complexity is multiplied by the number of fault locations), e.g., [98]. Depending on the particular attack, the target for fault injection can be a word (byte/nibble) or a series of bits. Other than flipping bits, different models can be employed where particular bits are set to 1 or reset to 0 [34]. For byte-oriented ciphers like AES, the random byte fault is most commonly assumed.

Slight variation of the above models can also be found in the literature. For example, the *neighborhood fault model* TRIVIUM [62] assumes that any number of bits in a neighborhood of few bits of a stream cipher state can be flipped — this type of assumption is meaningful when the implementation is bit-sliced (which is normally the case) and a LASER induced *instruction skip* attack (such as the practical attack described in [46]) can do it.

2.4 Information Theoretic View

Few works attempt to interpret fault attacks (so far, these works focus only on differential fault attack which is described in Section 5.1.1) from an information theoretic point-of-view. The objective is to find out whether the information leaked by the faults are optimal or there is any scope to utilize the information further. Examples include [108, 155].

2.5 Other Aspects

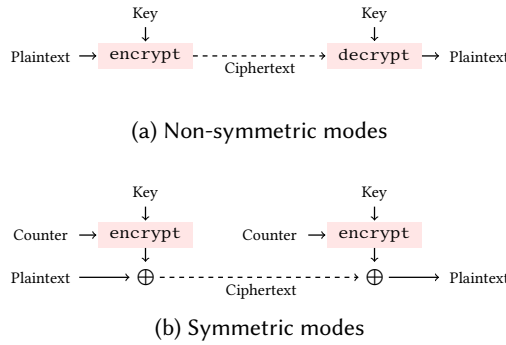


Fig. 1. Operations in two types of block cipher modes

Following [15, Section II.D], we classify block cipher modes into two categories: Non-symmetric and Symmetric modes, as shown in Figure 1. In non-symmetric modes, the original plaintext is encrypted with the `encrypt()` subroutine; but decrypted with the `decrypt()` subroutine; examples include ECB, CBC. In contrast to this, in symmetric modes, a counter/IV is both encrypted & decrypted with the `encrypt()` subroutine, the result is XORed with the plaintext (like a stream cipher); examples include CTR, OFB, CFB. As noted in [15, 110, Section 7.1]; symmetric modes have properties that

can be useful to resist certain type of fault attacks (DFA, in particular). Except these two works, rest inherently assume ECB mode; to the best of our knowledge. Besides, fault attacks on block ciphers can target the main cipher routine or the key scheduling subroutine if it contains non-linear operations (such as the attack on AES key scheduling [1, 104]).

Nonce-based primitives generally can be considered relatively more difficult as the non-repeatability of nonce makes certain fault attacks (like DFA, see Section 5.1.1) not possible. The InDFA model (see Section 5.2.2) is proposed for such a case.

Another aspect to consider is for authenticated encryption ciphers that block the output if the verification fails (assuming the attacker cannot attack the decryption/verification circuit). This also makes DFA impossible but the *ineffective* faults (see Section 5.2.3) are still possible. The attacker can bypass this limitation by targeting the decryption/verification circuit.

3 DATA ALTERATION METHODS

3.1 Volatility

Based on volatility of faults, they can be classified either as *hard* (also known as *permanent*) or *transient* faults [170]. Hard faults assume that one/a few particular bit(s) in the device are permanently set some value. Even though this type is not so popular, it has been applied against, for example, the stream cipher based AEAD ACORN [64]. Transient faults, on the other hand, allow the device to get back to its normal operation flow when the source of fault is revoked. Generally,

all the hard fault models assume too much power for the attacker; hard to achieve in practice; and also easier to detect. One possible way to attain this scenario could be manufacturing defect or causing an irreparable damage to the chip. These attacks are apparently impossible to protect from a purely cipher design point-of-view, since they essentially change the cipher description. A new attack model, termed as the *persistent* fault model was proposed (refer to Section 5.4.2), which lies somewhat in between the transient and the hard fault models.

3.2 Modification of Operation

Under this model, the attacker is allowed to alter (skip, misinterpret or execute multiple times) a number of operations in a microcontroller. For example, it is shown that a well-aimed instruction skip can reveal a full secret key of AES [46]. Similarly, the attack on CHACHA in [109] substitutes one instruction with another – addition operation was effectively changed into subtraction, allowing fault analysis.

These models are too powerful to protect from a cipher design perspective, as the attacker can effectively alter the cipher description and recover the key easily. In the most extreme case, it may reduce to a situation where the operation actually performed hardly qualifies as a cryptographic one, e.g., skipping the call to the entire `encrypt()` subroutine. Nonetheless, this type of research paradigm is not uncommon in the community, e.g., [32, 71].

3.3 Modification of Operand

In this fault model, Eve is able to manipulate the operands during any phase of the cipher execution. Such type of attacks is most commonly used in practice.

The fault attacks that belong to the modification of operand category are: Differential Fault Attack (DFA, Section 5.1.1), Algebraic Fault Attack (AFA, Section 5.1.2), Impossible Differential Fault Attack (IDFA, Section 5.1.3), Collision Fault Attack (CFA, Section 5.2.1); Linear Fault Attack, Integral Fault Attack (LFA and IFA, respectively; described in Section 5.1.4) and Internal Differential Fault Attack (InDFA, Section 5.2.2). These analysis methods work based on the analysis of the propagation of the difference injected at the internal state (generally a few rounds before the final round); and are somewhat similar.

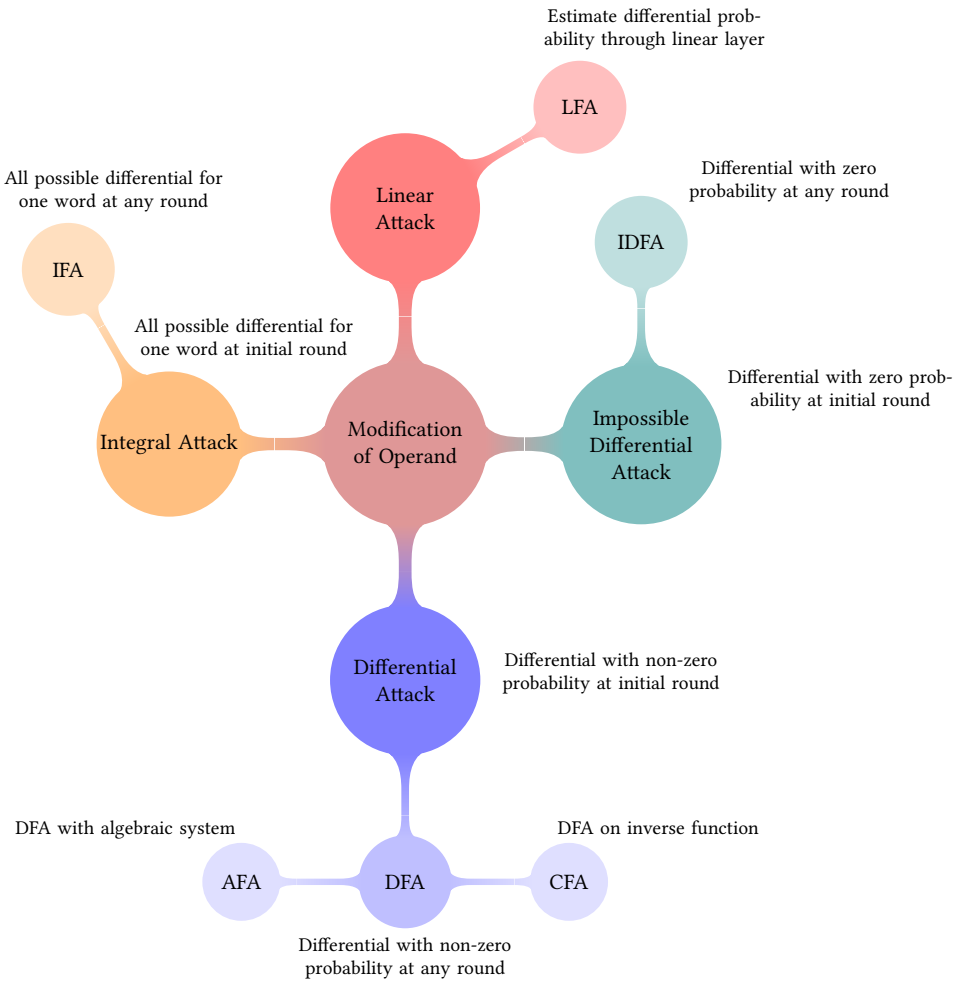


Fig. 2. Attacks (classical and fault) based on modification of operand models

In essence, all these methods result in a weakened (easier for Eve) version of the corresponding classical attack, as shown in Figure 2. More precisely, a classical attack can inject difference at one/more words at the very beginning of the cipher execution (such as, difference in the plaintext). This difference passes through all the rounds of the cipher. In contrast, in the corresponding fault attacks, the attacker can inject the difference at any round during the cipher execution, thus relaxing the model for her. As modern ciphers that are in use are designed to withstand classical attacks, putting the difference at the beginning would not yield any exploitable information to Eve. When she puts the differences near the end of the cipher execution (e.g., within the last three rounds for SPN block ciphers, see Section 5.1.1), she can lower the entropy in the ciphertext, giving her some information on the secret key. As a result, by using a few faults (sometimes with a single fault), she can recover the entire secret key. One may also refer to [156, Chapters 5.5, 6] for the analysis of such fault attacks from a classical attack point-of-view. Since the attacks in modification of operand category closely follow classical attacks; it may be possible to design a cipher which, by design, is capable of thwarting such fault attacks; at least to some extent. The only cipher to have such a claim is, DEFAULT [12, Chapters 7, 8] (see Section 7.1), which offers a non-trivial 2^{64} search complexity against DFA and variants (all those fault models mentioned in Section 5.1). DEFAULT is inherently different from CRAFT [28], which attempts to protect against DFA (to some extent) inherently; although it falls under the category of detective countermeasures (see Section 7.2 for more details).

Generally, the analysis procedure in these types of fault attacks consists of two orthogonal terms; namely, fault complexity and search complexity. It is commonly possible to extract the secret key by using many faults and a low cost searches; the same result can be obtained by using less faults and high cost searches. As the cost of computation up-to a certain complexity is negligible, whereas a fault might not be easy to perform at some cases; the attacker usually tries to keep the fault complexity minimal (say, within few 10's) while keeping the search complexity within a doable limit (say, less than 2^{40}). However, certain attacks require a few hundred or even a few thousand faults (refer to Section 5.1.1 for examples).

4 SOURCES OF FAULT INJECTION

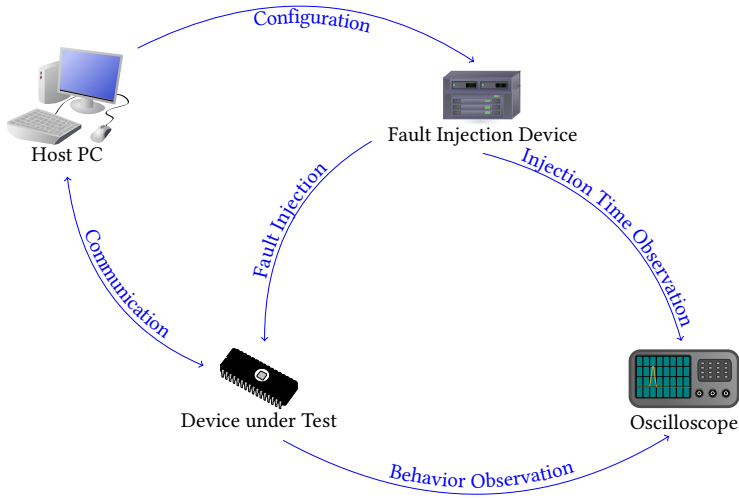


Fig. 3. Schematic view of a fault injection set-up

In this part, we briefly discuss on the equipment used to inject faults. Figure 3 shows the schematic of a fault injection set-up. A comparison of common tools is given in Table 1 (which is adopted with slight modification from [21]), where the most frequently used tools are highlighted.

The fault injection tools can be compared based on their properties. The first property is the effect of the fault injection tool. In this case, the effect could be global or local. Localized fault indicates that the adversary could precisely limit the effect of fault on the specific location or spot in the device, as compared to global fault where the attacker cannot really control where the fault is injected.

The second comparison is a requirement on the target device. De-packaging means that the outer layer of the device will have to be opened either through chemical (acid) or mechanical means, in order to access the chip inside. Damage refers to the state of the device after fault injection. For some fault injection tools, the target device might be destroyed. Hence, the choice of tools can be adjusted depending on the availability and importance of the target device. The last property under this category is the detail of the device design. Some of the tools required the knowledge of the device in order to properly inject the fault, while in other cases, partial or no knowledge is required.

The third comparison is about the accuracy of the fault injection tool. The time parameter refers to the timing precision when the fault is injected, and the position refers to precision of fault location in the target device. The next comparison is regarding the cost of the fault injection equipment. The cost is highly related to the accuracy, in this case, in order to achieve higher accuracy, the fault injection equipment will be more expensive. Lastly, the comparison is regarding the technical or expertise skill required to operate the equipment. In this case, for some specialized tools, such as LASER or focused ion beam, they might be more dangerous and can cause potential harm; and hence, a higher level of knowledge is required to safely operate the equipment.

Figure 4 shows various practical set-ups used to inject faults. A short discussion on most common set-ups is given next. For further information on these fault injection set-ups, one may refer to [107, Chapter 3.1].

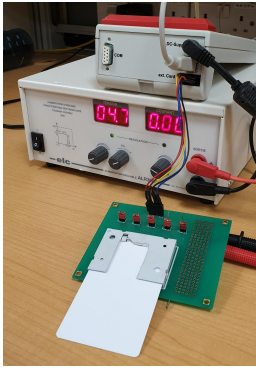
4.1 Clock/Power Glitch

If the device uses an external clock, then a sudden variation in the clock can result in a transient fault in the device. For example, the technique is demonstrated in [66]. A glitch in the power can

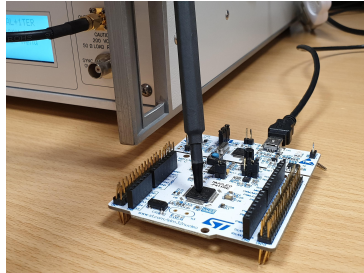

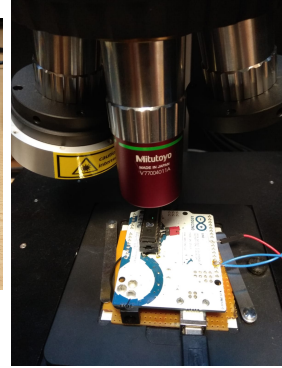

also result in a similar fault [126]. Glitch is an efficient, cost effective and commonly employed method for fault injection in practice, which also does not require too much technical expertise. It can be applied on both the pins as well as the die. However, it may be hard for a glitch based set-up to control the fault, for example, to inject all possible 255 faults in a byte fault setting; and also the faults injected may not be uniform.

4.2 Optics (LASER/UV-ray/X-ray)

Induction of faults by optical sources is another commonly used method. Often, this type of attack is done with a focused LASER beam at a particular location of the chip, e.g., [8, 162]. In this technique, the chip has to be de-packaged. Also, the correct location for injecting the fault has to be found by inspection, which requires specific expertise, time and expensive equipment. The advantage of this approach is that the fault can be precisely injected into the device, and thus, wider variety of fault model can be realized. A comprehensive categorization of various optical fault analysis set-up can be found at [133].

4.3 EM Emanation

We can further divide this technique into two categories. *Pulse injection* targets the digital blocks of integrated circuits, such as logic and memories. The cells in the chip can be effectively forced to produce erroneous output by a high energy EM pulse for a short period of time. As an example, one may refer to [122] for more information. It has a few advantages over other techniques. For example; effect of glitch is generally global to the chip, whereas EM emanation can be made local to a particular location by suitably placing the probe; it does not require de-packaging of the chip as in the case of optical fault, while maintaining almost similar level of fault precision. *Harmonic injection* targets the analog blocks, such as internal clock generator or random number generators. In this case the attacker generates a stable sinusoidal signal at given frequency, injecting a harmonic wave to create a parasitic signal biasing the behavior of the block. Such attack is more global and the duration of the signal is relatively long compared to pulse injection. More details on such setup can be found for example in [85].

4.4 Others

Besides the commonly used fault injection methods described before, there are also other techniques for fault injection include, for example, *row hammer* [105]. Row hammer is a known side effect in dynamic random access memory (DRAM). By repeatedly accessing a row in a DRAM, the attacker can potentially flip bits in adjacent rows. It is inducible by software, and can be repeated. Another source can be a hardware Trojan, as shown in [36]. Other examples include: *Temperature variation*, where forcing a chip to work outside its operating temperature can cause faulty operations [94], as well as *under powering*, where the faults are induced by reducing the supply voltage [161].

5 ANALYSIS METHODS

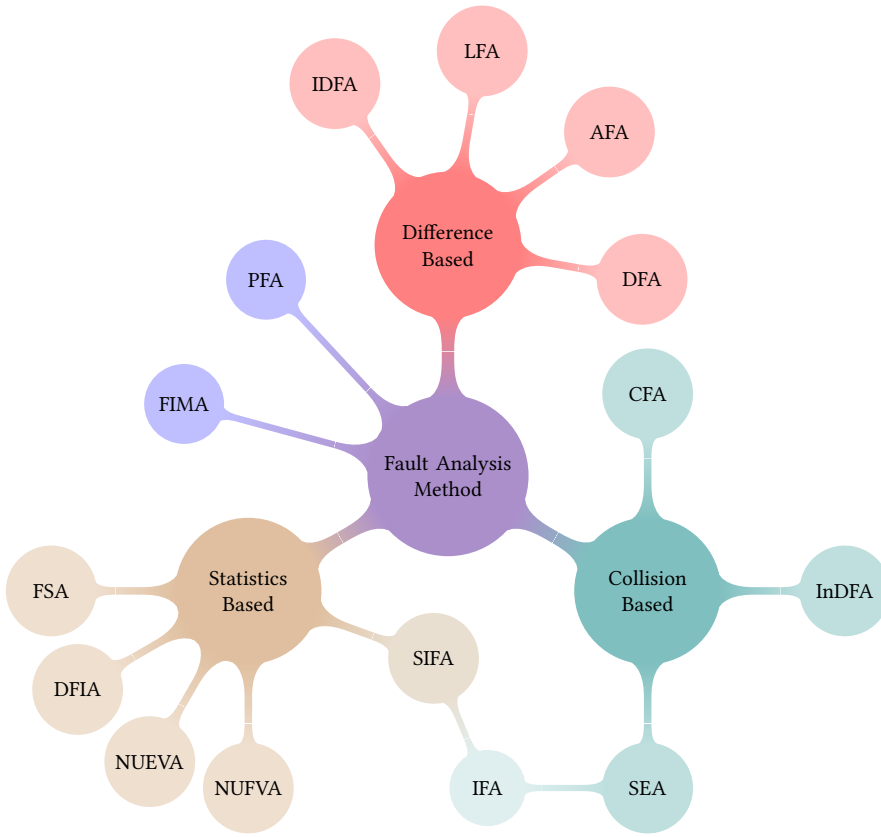


Fig. 5. Classification of fault analysis methods

Broadly, the fault analysis techniques can be classified in three major categories – differential (Section 5.1), collision based (Section 5.2) and statistical (Section 5.3). Figure 5 shows a general overview of the classification of various fault analysis methods. The *Statistical Ineffective Fault Attack* (SIFA, see Section 5.4.1) falls somewhat in between collision and difference based. Two other new methods, namely, *Persistent Fault Attack* and *Fault Intensity Map Analysis* (FIMA) are hard to fit in an exact category. These three methods are kept separate (Section 5.4).

5.1 Difference Based Fault Analysis

All the methods in the difference based analysis category are somewhat similar and can be thought of as an extension of DFA (which itself can be thought of as an extension of the classical differential attack). These methods exploit the confusion and diffusion characteristics of a cipher to inject a well-aimed fault that allows to obtain the desired difference distribution at the output of the cipher. In general, DFA and variants are more practical (such as require less number of faults) than ineffective or statistical models.

5.1.1 Differential Fault Attack (DFA). The concept of DFA is introduced in [31]. As already mentioned (Section 2), the attacker injects a difference at a round of her choosing. DFA is possibly the most commonly employed fault technique. Here we list a few relatively recent works on high profile ciphers: AES [3], TWOFISH [4], PRESENT [10, 96], PRINCE [166], MIDORI [52] etc.

To the best of our knowledge, the earliest round DFA on AES works at the 4th last round [61]. The *diagonal fault model* [148] proposes the best known DFA on AES (without using information from key scheduling), where the computational complexity is reduced to a nominal bound.

In general, the underlying philosophy of attacking SPN ciphers by various fault methods are somewhat similar (particularly those use a diffusion matrix, instead of bit permutation, as the linear

layer), and can be (to some extent) generalized from a theoretical perspective. We omit a thorough analysis here, as interested readers may find it in [156, Chapters 5.5, 6].

In order to give an overall idea, we present the simplest case of DFA on SPN. Here, the attacker injects faults at the last round SBoxes one by one. For each SBox S , she injects a fault δ and obtains a relation of the form: $S(x) \oplus S(x \oplus \delta) = \Delta(x, \delta)$; where Δ is known to her, x is the unknown input she wants to retrieve and δ is either known (deterministic model) or unknown (random model). Nonetheless, using the input difference – output difference relation of S , she is able to narrow down the solutions for x . Finally, with a few such relations, she is able to solve x uniquely. Now that she knows the state before the last SBox layer, she can compute the last round key by XORing the ciphertext with the output of the last SBox layer. In this approach, the fault complexity is maximized, and the search complexity is minimized.

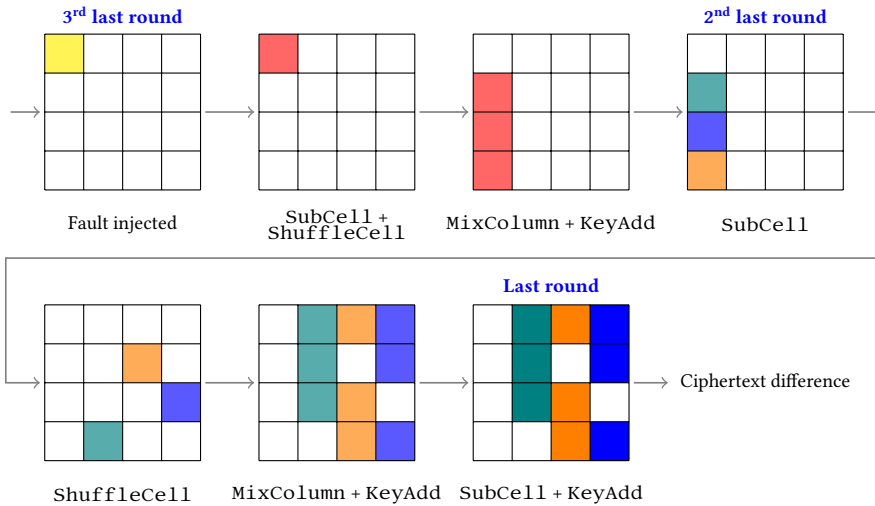


Fig. 6. DFA on MIDORI encryption at third last round

The fault complexity of the approach mentioned above can be reduced if the fault is injected a few rounds earlier. Let us assume the fault is injected at the beginning of the 2nd last round SBox. Then, the difference will spread through one permutation layer, where it enters another layer of SBoxes. Thus, one fault in a round effectively induces multiple faults on the next round, the number depends on the nature of the permutation (e.g., in case of a standard 4×4 SubByte-ShiftRow-MixColumn-AddRoundKey construction, one column, i.e., 4 faults are induced). However, in this situation, the fault-output differential relation becomes more complicated, which results in more

computation. In other words, injecting fault(s) at the penultimate round reduces the number of required faults at the expense of more computation. Now, consider the effect of injecting fault at the beginning of 3rd last round SBox. Thanks to the property of the permutation rounds, in common SPN block ciphers, the fault passes through 2 permutation layers before reaching the last round SBox; which generally results in activating all SBoxes at the last round. Thus, generally one fault in 3rd last round is equivalent to the naïve approach on each individual SBox with the overhead of computational cost (which is generally within doable range). Figure 6 shows one such case with the MIDORI block cipher, based on [52, Figure 2]. Here, the fault is injected at the (0, 0)th word of the MIDORI state at the beginning of the 3rd last round. This fault propagates through the following SubCell, ShuffleCell, MixColumn and AddRoundKey to other 3 words in that column. Thus, at the beginning of the 2nd last round, the attacker enjoys the effect of injecting 3 faults. These 3 faults induce a total of 9 differences at the ciphertext. So, the attacker effectively reduces the required number of faults to one-ninth from the last round attack.

As noted earlier, the SPN ciphers with the bit permutation as the linear layer act a little differently. For example, in DFA on PRESENT the fault propagation pattern spreads bit-wise through the state because of the cipher’s pLayer (which depends on the value) [36]. If a nibble gets affected in PRESENT, it spreads into 2 – 4 nibbles in the following round. Therefore, if the attacker manages to make the output of four chosen nibbles in round i faulty, it might spread into the whole state in round $i + 1$. Together with the differential characteristic of the sBoxLayer, it will reduce the number of input candidates per nibble to 2 – 4. Then, if the fault is injected into different four nibbles, and therefore, different input bits of the SBox in round $i + 1$ get affected, the input candidates of each nibble might be known. After this step, the attacker simply recovers the last round key and computes an inverse key schedule to get the secret key.

The FAs on the Feistel block ciphers are of more variety, because the analysis of these attacks depends on the following (non-exhaustive) list of factors:

- Choice of the f function,
- Whether whitening keys are used,
- How the round keys are inserted (through a linear function or a non-linear function),

- Number of branches.

Hence, it is difficult to generalize all the attacks here. One may refer to [35] for DFA on a few Feistel block ciphers; namely, DES, MIBS, TWINE and CLEFIA.

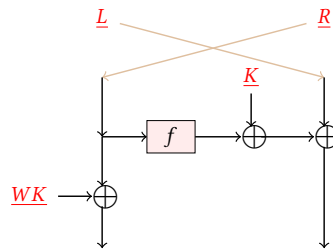


Fig. 7. Last round of many Feistel network based ciphers

However, the last round of several high profile Feistel network based ciphers (such as CLEFIA [2], TWOFISH [4] and PICCOLO [95]) can be modelled as in Figure 7. As for the notations, L and R denote the left and right branches, K as the round key and WK as the whitening key, f as the Feistel function, and red indicates it is unknown to attacker. One can view $K \oplus L$ as the final round key addition in an SPN cipher, and thus DFA can be launched as in the case of a SPN. Once the input of the Feistel function f is identified, WK can be uniquely determined. Now, the attacker can perform a similar strategy on the previous round to determine the value of L and thus recover K from the previous round as well, etc.

DFA or its variants can be successfully applied to any unprotected symmetric key cipher. Interestingly though, we notice that there are several stream ciphers on which no DFA or its variants (see AFA, Section 5.1.2) are reported so far. In [106], the authors present a DFA on the stream cipher HC-128 where the attacker is allowed to inject fault at a random word of the state of the cipher but cannot control its exact location or the resulted value of the word. Normally, DFA/AFA on stream ciphers is considered difficult to carry out in practice, compared to block ciphers, as the analysis complexity often goes beyond the computational requirements of automated tools such as satisfiability (SAT) solvers. One may check eSTREAM finalist SALSA or its variant CHACHA in this regard [27].

As an interesting side note, it may be observed that, the complexity of a DFA (or its variant) may be increased if the following design choices are incorporated in a stream cipher design:

- Suppress several key-stream words (say, output every two hundredth key stream bit in TRIVIUM).
- Use constructions with bigger state which are (possibly) difficult to solve by SAT solvers.
- Value – position swap (as in RC4) such that fault equations are hard to formulate.
- Use block ciphers with CTR or any other non-symmetric mode (it inherently works like a protocol level countermeasure, see Section 2.5).

It is not long since the faults attacks on hash functions or other primitives that use a hash function appear in the literature. As hash functions are commonly underrepresented in fault attacks, here we present a compact overview of major fault attacks.

The first such attack is reported by Li et al. in [112] against SHACAL1, a block cipher employing SHA-1 without the final addition operation. In [90], the authors argue in favor of analyzing public primitives like hash functions or their internal compression function in the light of DFA, citing reasons that the impact of the result will get amplified in applications like HMAC or key derivation

functions. They extend the attack of [112] to include the final addition and demonstrated a DFA on SHA-1 compression function using 1000 faulty outputs. The authors conclude that applications using the SHA-1 compression function having fixed input and output which are known to the attacker are particularly vulnerable to their attack.

In [73], the authors demonstrate a DFA on the hash function GRØSTL which was an AES based finalist of the SHA-3 competition. They indirectly make use of the classical DFA on AES along with some precomputation to invert the output transformation using 16 faults and required 280 faults on average to invert each compression step attacking both GRØSTL-256 and GRØSTL-224. They were able retrieve the key of HMAC-GRØSTL using 300 faults and also present a possible countermeasure using a modification of the truncation function. In [145], a diagonal fault analysis attack is reported on GRØSTL when used in dedicated MAC mode that makes use of the notion of fault repeatability introduced in [141]. The number of faults to invert the output transformation is reduced from the previous record of 16 to 8.

The first fault attack on the SHA-3 standard is presented in [11]. The main result in this paper is a DFA on SHA-3 variants SHA-3-512 and SHA-3-384. The authors showed that using a random bit fault model, 1592 bits among the total of 1600 bits of the internal state of SHA-3 can be extracted using 80 faulty messages given the first 320 least significant bits. This gives the indication that it is indeed possible to recover (most of) the state of a compression function even if the full state is not available to the attacker (only a truncated state is available). The idea of the attack is based on the DFA models used in GRØSTL [73] and STREEBOG [6]. The ciphers, SHA-3-224 and SHA-3-256 are attacked in [118], where they adopt more realistic single byte fault model to mount DFA. In [116], the first algebraic fault analysis of SHA-3 family is reported, where they argue in favor of AFA being a more effective technique as it recovers more bits per fault injection and also more efficient since it required lesser fault injections compared to the DFA results. Moreover, they report that AFA is more suited for SHA-3 as it could exploit the inherent algebraic properties of SHA-3. The main result is to recover the internal state of the penultimate round using a random byte model. The work is extended in [117] where the authors use more relaxed fault models using 16 and 32-bit faults and found the attack to be more effective for shorter message digests.

STREEBOG, the Russian hash function standard, was analyzed in the light of differential fault analysis attacks [6]. They used the random bit-flip model and also discussed the scenario where the fault location in the state can be controlled. They demonstrated a two-stage attack which recovers the compression function inputs with number of fault injection ranging between 330 and 1640 based on certain assumptions.

DFA was also applied against the AEAD MINALPHER in [50], which is a second round CAESAR³ candidate. Using a single fault at a fixed position, almost universal forgeries on the third round CAESAR candidates, CLOC and SILC were shown in [143]. In [23], DFA on AEGIS-128L (which is in the final portfolio) and TIAOXIN-346, two candidates of the CAESAR competition were reported. The authors commented that the ciphers following a stream cipher design paradigm and a particular form of update function are vulnerable to similar attack.

5.1.2 Algebraic Fault Attack (AFA). The notion of AFA [57] is similar to that of DFA. The difference between AFA and DFA lies in the process analyzing the faulty and non-faulty outputs. DFA relies on astute observation done manually on the difference propagation through the cipher, thereby solving the unknown state of the cipher. AFA relies on forming algebraic equations and commonly feeding the resulting system of equations to a Boolean satisfiability (SAT) solver thereafter. AFA

has been successfully applied against block ciphers (e.g., LED [97, 178], PICCOLO [175]) and hash functions such as SHA-3 [116].

It may be noted that AFA is particularly useful against stream ciphers and stream cipher based designs; as it is relatively straightforward to get the algebraic equations in the computer rather than manually exploiting structure of the cipher. Observing differential trails manually is tedious in such cases. For example, AFA against ciphers in GRAIN family [63, 157], TRIVIUM [62], SPROUT [119] etc. were reported. ACORN was also analyzed in [165] (where few bits are exhaustively searched, and the rest are solved by the SAT solver) together with GRAIN-v1 and LIZARD (in the latter case, the state recovery at a particular round was shown to be possible). The first step in these attacks is to deduce optimal places for fault injection. Generally, precise location and round of fault injection is considered unknown to Eve (to be determined the difference pattern in the key-stream, which is referred to as the *fault signature*) although Eve controls which (part of) LFSR–NLFSR is affected. However, in these stream cipher related attacks, the authors describe their works as DFAs (not AFAs), possibly because the typical DFA approach that works (without involving automated solvers) on block ciphers does not work in stream ciphers. Section 5.1.1 points out few ideas on how it could be possible to make a stream cipher more resistant to AFA.

As for the AEADs, the finalist in the first CAESAR portfolio (lightweight applications); ACORN was analyzed by AFA (by assuming few bits are known to the attacker) in [165], and also in [176] where the feasibility of a DFA was discussed and verified with a toy version of ACORN. Two other CAESAR candidates, AEGIS which is a finalist in the second portfolio of CAESAR (high performance applications), and TIAOXIN which is a third round candidate were analyzed by DFA (technically, AFA) in [65].

5.1.3 Impossible Differential Fault Attack (IDFA). The underlying concept of IDFA [30] is similar to classical impossible differential attack (IDA), where the attacker looks for probability zero differentials instead of high probability ones. Once such a differential is chosen, the attacker checks which sub-key guesses produce this differential. Those sub-key guesses are then discarded as they cannot lead to a correct key guess. IDA utilizes input difference to get a differential, whereas IDFA makes use of fault to achieve the same. IDFA was successfully used against AES, e.g., in [61, 134].

5.1.4 Linear Fault Attack/ Integral Fault Attack. Two other types of fault models were proposed which resemble two classical cryptanalysis techniques. The linear fault attack (LFA) [114] is a fault based generalization of the linear cryptanalysis. Similarly, the integral fault attack, described in [134] and later in [156, Chapter 6.3], is the fault based generalization of the classical integral cryptanalysis. In the LFA scenario, Eve tries to recover the information regarding the fault through the output from a (non-linear) component appended to it by means of linear approximation. The number of pairs of output required for the attacker to successfully apply LFA is of the order of $c \times \epsilon^{-4}$, where ϵ is the linear bias ($c \times \epsilon^{-2}$ pairs of output would be needed to apply linear cryptanalysis) and c is a small constant (typically, 4). For the integral fault case, she repeats all the possible faults for a word, effectively simulating the integral attack. Note that, this model can be hard to achieve in practice, and requires sophisticated equipment; also it is worth mentioning that such model has never been reported with any practical attack set-ups up to date.

5.2 Collision Based Fault Analysis

5.2.1 Collision Fault Attack (CFA). CFA was proposed in [33] and independently in [89]⁴. The concept was used against IDEA [56]. In CFA, the attacker, Eve, gains information about the secret

key if the outputs, obtained from a normal (non-faulty) encryption and from a faulty encryption, are equal. She arbitrarily chooses the first plaintext P_0 and obtains the corresponding faulty ciphertext: $C' = E'_K(P_0)$ (here E_K is the encryption operation and where E'_K denotes the faulty invocation of the encryption operation with secret key K). Then, she asks for encryption of another input, P , which might give an output identical to C' (i.e., $E(P) = C = C'$). Such collision can be then used to get an information about the intermediate state of the cipher, and consequently, about the secret key. Unlike DFA, the fault is normally introduced in the early rounds of the cipher, exploiting the property that the propagation of the fault in the intermediate value will result in a collision with the normal output.

One natural problem that arises is, how to find two such colliding inputs; as the cipher is expected to have a very good diffusion. Eve solves this problem by utilizing differential properties at early rounds (to avoid much diffusion). Therefore, unlike DFA, the fault is normally introduced in the early rounds of the cipher, exploiting the property that the propagation of the fault in the intermediate value will result in the collision with the normal output. Hence, one can consider a CFA on E_K to be similar to the DFA on E_K^{-1} . Interchanging the input & output for CFA, the situation becomes: Two identical inputs are fed to the system, at a later round one fault is applied, then the outputs become different; which is the case for a DFA.

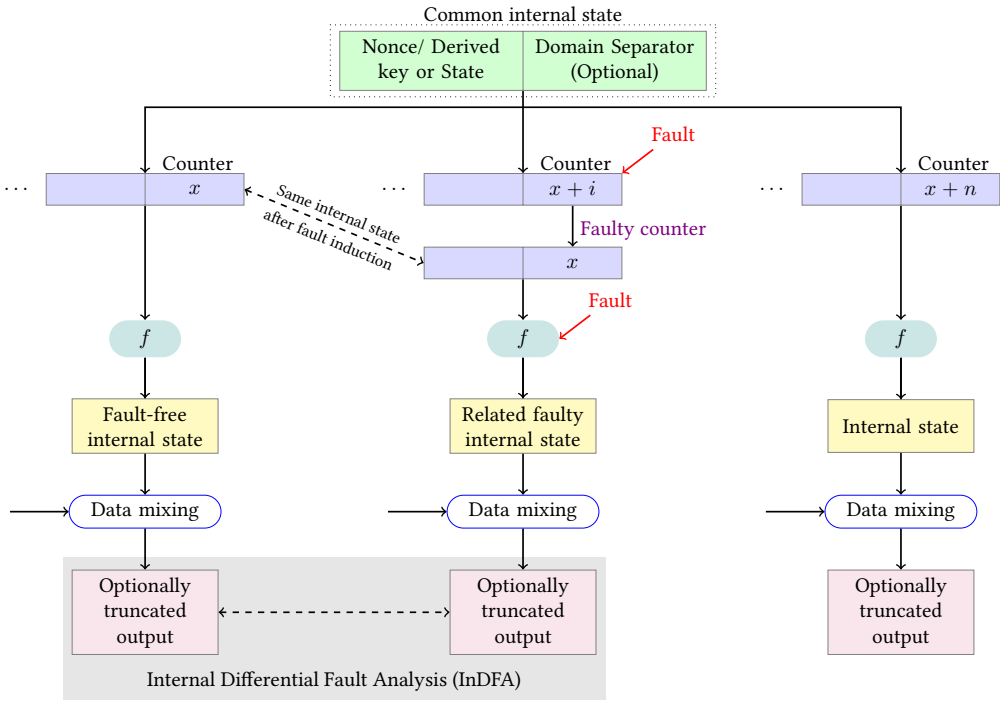


Fig. 8. Generic model for using internal differentials in fault analysis of parallelizable ciphers in the counter mode

5.2.2 Internal Differential Fault Attack (InDFA). The Internal Differential Fault Attack [146, 147] mainly leverages upon the internal symmetry of a cipher. The ciphers which are employing a parallel mode of operation are the most vulnerable to this kind of analysis. The idea of InDFA is to overcome the nonce barrier that acts as an implicit guard against DFA, as the nonce is not allowed to repeat. This guard can be removed when faults are injected at some counters of the parallel branches (which differ minimally at the inputs). This can result in both branches having same inputs, as the faulty counter gets the same content as the non-faulty counter. The rest of the analysis can be done similarly to DFA. In other words, the attacker injects a second fault in the internal state of any of the (currently identical) branches. This second fault propagates through the rest of the state. The effect of this fault can be utilized by DFA to recover secret information. Refer to Figure 8 for a visual representation of the scenario. The InDFA model was applied on the CAESAR candidate PAEQ [146].

5.2.3 Safe Error Analysis (SEA)/ Ineffective Fault Analysis (IFA). Similar to the CFA model, the SEA [99, 171, 172] model makes use of the situation when the fault introduced in the cipher does not alter the output. To achieve this, intermediate bits are changed and the information whether the output changed or not is used to determine the non-faulty content at the time of the fault injection. Generally, this attack works by recovering one bit at a time; so, as many faults as the state size may be required. It may be noted that the SEA requires a strict adversarial model. IFA [53] is a special type of SEA where the injected fault has no effect.

SEA attacks are able to break many countermeasures that do not withhold the output in case a fault is safe (that is, the fault does not change the output), but they do otherwise. In that case, SEA is able to utilize the information whether the output is withheld or not.

IFA was used to recover the secret SBox of the block cipher KUZNYECHIK (a Russian standard) [5]. In addition, the authors also presented a DFA with the random byte fault model in the same research paper.

5.3 Statistics Based Fault Analysis

In this third category of fault analysis, the statistical distribution of a variable is considered, which is biased because of the nature of fault injection. Generally, the underlying models assume more powerful adversary compared to difference based method, and are of stuck-at type. The details on

practical implementations on such fault models can be found in [125]. Further, the authors also showed the connection among these models and gave a comparison on efficiency. More information on each of the analysis methods are given later.

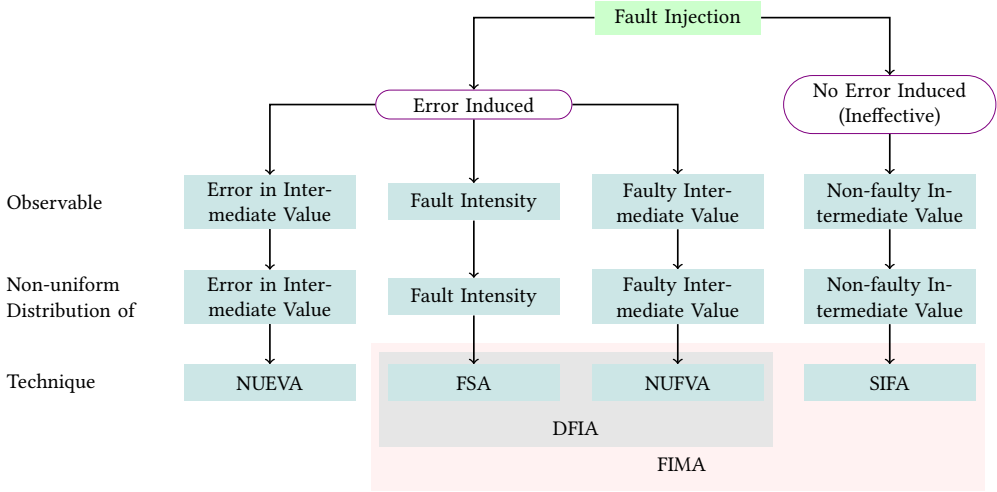


Fig. 9. Overview of statistics based fault analysis methods

An abridged taxonomy of statistics based fault attacks (adopted with slight modifications from [138, Figure 1]) is given in Figure 9. The terms, *Non-Uniform Error Value Analysis* (NUEVA, Section 5.3.1) and *Non-Uniform Fault Value Analysis* (NUFVA, Section 5.3.2) are adopted following [125, 138, 139].

The following description of the terminologies are adopted (with slight modification) from [76, Section 2.1]:

- **Fault Intensity** Fault intensity is the strength by which a device is forced to work under non-favorable conditions (that may effectively induce a fault). For example, in case of clock glitch as the source of fault injection, the fault intensity refers to the shortened clock cycle.
- **Fault Sensitivity** The fault sensitivity is the minimal fault intensity at which a device starts to show faulty behavior. For example, in case of clock glitches, the fault sensitivity generally corresponds to the critical path.
- **Biased Fault** A biased fault refers to the gradual change in the faulty behavior of the device, which is a result of gradual change in fault intensity.

The *Differential Fault Intensity Analysis* (DFIA, Section 5.3.4) uses the biased fault model described above that is based on minimal bias (e.g., flip of one or two bits); and it relies on side channel leakage. Here, side channel information generated by a countermeasure to a fault attack (such as starting time of an alarm or time of premature stop of a cipher execution) is used. Hence, the

knowledge on the fault and the fault-free computations is not necessarily required. Notice that *Fault Sensitivity Analysis* (FSA) is considered one variant of DFIA under the current taxonomy. On another note, FSA and NUFVA do not require the knowledge of the faulty output.

5.3.1 Non-Uniform Error Value Attack (NUEVA). In NUEVA [111], the fault value (which acts as a mask) is considered as the variable of interest and the non-uniform distribution of it is observed. This non-uniformity in distribution can be caused by, e.g., the Hamming weight of the fault value.

5.3.2 Non-Uniform Faulty Value Attack (NUFVA). This model was proposed in [74]; where the biased distribution of the state was considered. This bias is caused due to the result of the fault injection technique. For example, it was shown in [125] that certain fault values will more likely appear than the rest.

5.3.3 Fault Sensitivity Analysis (FSA). FSA [113] exploits the behavior of underlying hardware when exposed to faults. This behavior changes with the change of the intensity of the fault injection. This behavior is a potential source of side channel information to the attacker. She does not need the output to analyze, instead she checks the data dependency for each intensity. The attack procedure is therefore related to side channel analysis. It tests the circuit by varying the intensity of the injection and checks the data dependency for each case. In the actual attack procedure, Eve collects the input to the cipher, non-faulty output, and the side channel information. After this, the correlation coefficient is used to find the most likely sub-keys.

5.3.4 Differential Fault Intensity Analysis (DFIA). This method [77] combines fault injection with side channel attack set-up. Similar to FSA, it tests the system responses under different fault intensity and takes advantage of a non-uniform distribution of the faults (biased fault model). Afterwards, it treats the biased fault model as the source of leakage and applies side channel methods. However, unlike FSA, it does not require a fault sensitivity profile of the attacked device. DFIA has been successfully applied against AES [77], PRESENT and LED [76].

5.4 Others

5.4.1 Statistical Ineffective Fault Attack (SIFA). SIFA [66] lies somewhere in between the IFA (Section 5.2.3) and SFA (Section 5.3.2). Similar to IFA, SIFA utilizes the probability that a fault injection may not result in a successful alteration in the device (ineffective fault). The main observation that works in SIFA is that the probability of error as a result of a successful ineffective fault injection is non-uniform. The bias can be observed in case of a correct key guess, but not for the cases where the key guesses are wrong. Since SIFA uses an ineffective fault model too, we keep it separate from the statistics based fault models. A SIFA on the ASCON AEAD, which is a finalist in the CAESAR portfolio for the use case 1 (lightweight applications) was reported in [139]. Another SIFA is reported on GIMLI in [83]. SIFA can be used to break existing fault countermeasures (see Section 7) that are used to protect against DFA and other common fault methods. Therefore special techniques are required for this purpose, more information can be found in Section 7.7.

5.4.2 Persistent Fault Attack (PFA). Recently, another category of biased fault injection is introduced, based on the fault duration. The fault model, known as the *persistent* fault, is proposed as a hybrid fault model between commonly used transient and permanent faults. Unlike transient fault, it affects several calls of the target function, however, persistent fault is not permanent, and disappears with a device reset/reboot. Based on this fault model, a statistical analysis technique is developed, called *Persistent Fault Analysis* (PFA) [174], to attack block ciphers. The attack targets the (common) SBox table stored in memory for a serialized implementation, with one fault injection altering any one element in SBox. The adversary collects several ciphertext resulting from this faulty SBox, to statistically recover the key. PFA is shown to break redundancy based fault countermeasures. Application of PFA can be found in [49] and [177].

5.4.3 Fault Intensity Map Analysis. FIMA [138] generalizes the statistics based fault models, taking into account all the relevant variables and the side channel information. So, it can be considered as the common method for FSA, DFIA, NUEVA and SIFA. This method utilizes the bias that is introduced by faults in the distribution of any of the relevant variables (faulty, non-faulty or the fault value), and the information on the fault intensity. As such, it can work with less amount of data than the predecessor methods.

6 GENERALIZED FAULT ATTACK AUTOMATION FRAMEWORKS

As fault attacks are becoming a more serious threat, efforts have been made to construct a generalized and automated framework that can evaluate the effectiveness of the attack and provide recommendations for cipher implementers, on which they can spot vulnerabilities and judge if they want to make their algorithm more robust. Conceptually, it can be described as follows: Given a cipher (and possibly a platform-specific implementation), such tools will automatically look for vulnerability; thereby cutting off the manual labor and expertise required to perform such attacks which is often error-prone [40].

The overall trend in this area, along with the possible challenges, can be deduced from the recent publications. Basically, the methods that focus on fully automated analysis always utilize some sort of automated solver, such as a SAT solver. While this solver can provide a formally-proven output, the quality of this output always depends on the input that has to be constructed by the analysis framework. It is an open problem to have a universal transformation framework which would take a cipher representation in any form and construct set of equations for a solver. Another challenge is to provide automated analysis on protected implementations — so far, the above mentioned works only focus on unprotected implementations since they only consider a single fault adversary. To be able to bypass most of the countermeasures, it is necessary to have a multi-fault adversary

model; e.g., in case the attacker wants to break a simple redundancy countermeasure only with fault injection attack, she needs either to inject the same fault into both branches of the execution, or inject a fault into one branch and then into the comparison module. Next, we will explain the working principle of the main works in this area, divided into cipher level techniques and implementation level techniques.

6.1 Cipher Level Approaches

The first idea of automating cipher-specific fault analysis is aimed at AFA [173]. It requires manual interpretation of the cipher representation in an algebraic form and then a SAT solver is used to find the vulnerable spots. The first automated framework focused on DFA [103], requires a manual identification of non-linear operations in a cipher. It then proceeds with finding a fault propagation pattern through the cipher rounds which is represented by colors – if a value served as an input to a non-linear operation, the output of this operation is assigned a unique color so that the number of these operations can be determined from the fault until the output of the cipher.

Later, several fully-automated cipher level frameworks emerge in the literature. Some of the proposed works have adopted the machine learning methods to identify vulnerable spots in the ciphers, based on existing fault attacks observed or learned on different ciphers. The work in [153] adopts the association rule mining to explore fault vulnerabilities on DFA, whereas the work in [151] uses random forest to identify solvable algebraic representation for AFA. Later, a framework is proposed in [154] that estimates the attack complexity required to recover the secret. To find a distinguisher, a data-mining approach was utilized in this case. A synthesis approach to find vulnerable locations from a high-level specification was proposed in [144]. While works generally focus on block ciphers, the authors in [158] attempted to fill the gap for stream ciphers. Recently, this work has been improved in [18] by substituting correlation coefficient (used in [158]) by machine learning.

6.2 Implementation Level Approaches

In case of *software level* techniques, there are two works focusing on analyzing assembly implementations. The work in [41] aims at unrolled microcontroller implementations and shows that some vulnerabilities are not visible from the cipher level perspective. For example, when permutation layer is combined with the substitution layer in block ciphers into a form of look-up tables, it introduces new vulnerabilities that cannot be estimated from the algorithmic representation. However, this work leaves the final step of the attack, namely, the analysis of DFA equations, on user. This task is later completed in [93] which utilizes Satisfiability Modulo Theory (SMT) solver to automate this last step.

The *hardware level* approach is presented in [48, 75]. This framework takes the hardware description of the cipher and creates a fault list based on exploited fault model. This is represented in a Conjunctive Normal Form (CNF) which is analyzed by a SAT solver. For implementation based approaches, the authors argue that the requirement for cryptanalyst expertise could be minimized, since the algebraic representation solely depends on the implementations themselves, rather than the cipher description. Recently, a method to minimize the countermeasure overheads based on identifying vulnerable regions was proposed [168].

7 COUNTERMEASURES

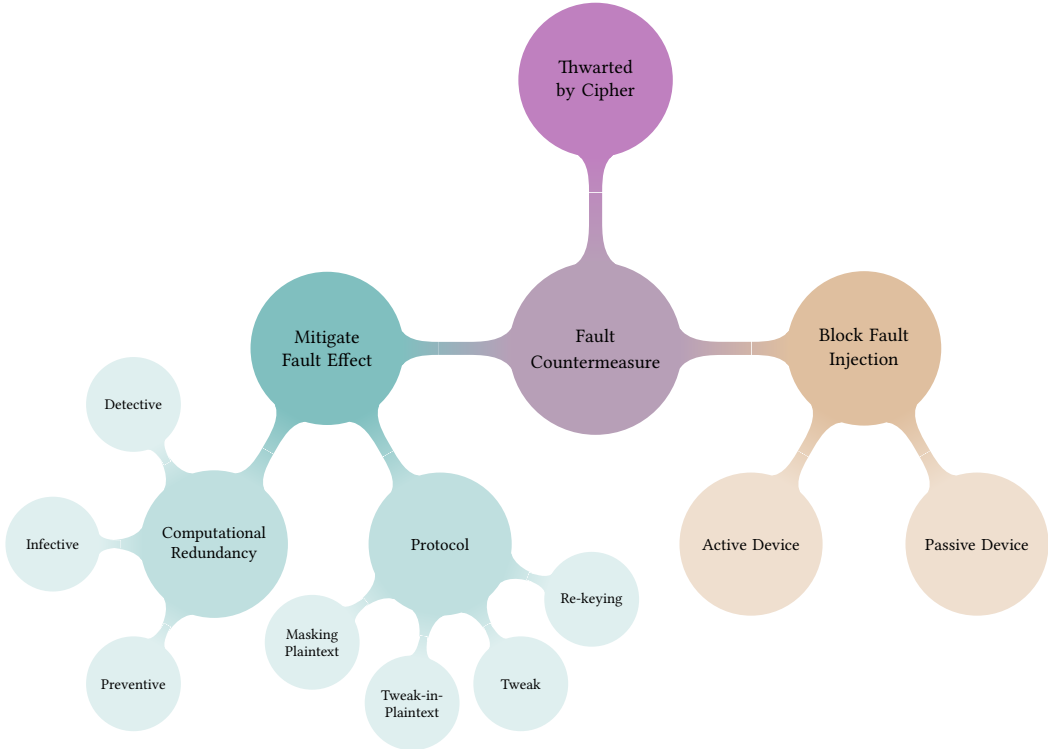


Fig. 10. Generic overview of fault attack countermeasures

The fault attacks are usually not prevented at the cipher design level. Instead, the cipher designer has to rely on the circuit implementer/secure software developer to ensure that an adequate countermeasure is deployed. Hence, countermeasures are designed and analysed separately from the ciphers, as we discuss here. For the sake of simplicity, we do not include the combined fault

and side channel countermeasures. A compact view of the countermeasures is presented in Figure 10. Overall, the countermeasures can be divided into two main categories. In the first category, the countermeasures try to prevent the fault happening in the first place (achieved through a specialized device). In the second, the countermeasures try to eliminate the effect of the fault either by means of redundancy or protocol.

All the countermeasures that mitigate fault effect utilize some form of redundancy to achieve protection against FA. The following classification shows the three classes based on the part where the redundancy is introduced:

- (1) **Cipher Level.** The security against fault attacks solely come from the virtue of the design itself (Section 7.1). Hence, no redundant computation is needed.
- (2) **Using a separate, dedicated device.** These devices are not related to the cipher. These devices can be *passive*, where a shield is used to block external interference [20]. It may be possible to peel off the passive layer using chemicals or precise milling tools, such as Ultra Tec ASAP-1. Alternatively, *active* devices can be used (such as, a sensor that detects any potential stress [86, 88, 179]).
- (3) **Using redundancy in computation.** The common procedure for these types of countermeasures is to duplicate (fully/partially) the circuit. This duplication can be in the spatial domain or the temporal domain, or a precomputed signature can be used to check integrity [107, Chapter 3.4]. Then, some predefined procedure to handle the situation of a fault detection is used, such as not producing any output or producing a random output.

- (4) **Using protocol level technique.** The communication protocol between Alice and Bob ensures that the probability for a successful fault injection is negligibly small.

The countermeasures in the category 3 that use redundant computations are quite well-studied. Those can be further classified into *Detection* (Section 7.2), *Infection* (Section 7.3), *Prevention* (Section 7.4), which are described later. The protocol level countermeasures are generally one among *Re-keying*, *Tweak* and *Tweak-in-Plaintext*, *Masking plaintext*; which are combined subsequently (Section 7.5). Before going into particulars of each of these types, we first briefly mention the role of the so-called *Double Fault* in this context.

Double Fault

Given the fault attack countermeasures (see the subsequent parts), a particular model may be of interest, which we refer to as the double fault model. The notion is adopted from [17, Section 2.6]. Note that, the detective and the infective countermeasures work by running two identical instances of the cipher. The inherent assumption here is that the attacker cannot inject identical faults in both the *actual* and the *redundant* instances. Under the double fault model, however, it is assumed that Eve can inject identical faults in both the actual and redundant instances. This model is shown to be practical in [163]. Since both the redundant and the actual computation results in the same output (since identical faults are injected), the countermeasure will treat this case as no fault, and return the (faulty) output to the attacker. This is a generic problem against detection and infection – if higher than double redundancy is not used. If such models are considered within the scope, *protocol level* or *preventive* countermeasures can be used. Note that, any cipher level protection (see Section 7.1) does not duplicate, hence is free from the double fault model.

Another interesting aspect of the double fault model is whether it is to be considered within the single fault or the multiple fault adversary model (see Section 2.2). Basically, the answer depends on the precise definition of the term ‘one execution of the cipher’. To be more specific; consider by ‘one execution’, we refer to the complete system (both the actual and the redundant instances) – in this case, we consider the double fault model outside the scope of single fault adversary model. On the contrary, consider the scenario where we refer to a single execution of the cryptographic algorithm designed by a cryptographer as “one execution of the cipher”; here the attacker injects faults once per one execution; so the single fault adversary model is maintained. For the sake of consistency, we stick to the second notion, so we do not consider the double fault model as a violation of the frequently used single fault adversary model. The recently proposed CRAFT [28] cipher has an in-built mechanism to protect against the double fault (see Section 7.2 for more information on this cipher). This model of double fault can be generalized for more faults, such as the triplication based countermeasure proposed in [22]. Note that, this notion of “double fault” is different from [138, 139], where the same term refers to attacking a pair of SBoxes at the same round.

7.1 Cipher Level

This is a new genre of fault protection which solely relies on the careful choice of design parameters of the cipher. This is introduced in the form of the cipher DEFAULT [12, Chapters 7, 8] (and also in [13]); and so far is the only of its kind. Basically, DEFAULT is composed of DEFAULT-LAYER (28 rounds) – DEFAULT-CORE (24 rounds) – DEFAULT-LAYER (28 rounds), where DEFAULT-LAYER is good against DFA and bad against the classical differential attack, and DEFAULT-CORE does not claim any DFA security. Overall, the whole cipher runs for 80 rounds, which is comparable to a lightweight cipher duplicated (this is reasonable, as the common DFA countermeasures rely on duplication). Also, the design is not fixed, namely any cipher with proclaimed classical security can be used instead of DEFAULT-CORE to have a DFA security. To the best of our understanding, it is not possible

to have cipher-level protection against fault attacks that do not employ DFA at its core (since the attacks inherently perturbs the description of the cipher itself).

The fundamental observation which leads to this DFA security of DEFAULT-LAYER is due to the presence of non-zero *linear structure* (LS) in its SBox, 037ED4A9CF18B265. In general, such SBoxes are not used in cipher design due to undesirable properties with respect to various classical attacks. In that sense, this design opens up a new paradigm for cipher construction. Also, it may be noted that DEFAULT does not necessarily protect against

7.2 Detection

Detection based countermeasures⁵ aim at detecting an anomaly. After it is detected, a predefined recovery procedure can be launched to stop the attacker from getting any information regarding the faulty output (the output from the cipher is suppressed or a random output is returned). These methods try to detect any data modification due to fault injection, deploying methods from coding & information theory, such as linear parity, non-linear (n, k) codes, representing data in *wave dynamic differential logic* [44] etc.

In [115], it is commented that detection based countermeasures that rely on error correcting codes are difficult to adopt in cases where side channel security (such as masking) is needed. Therefore, researchers try to design a countermeasure which is capable of protecting against both [37, 159]. Ways to find efficient codes and to evaluate the encoding-protected cipher implementations are studied in [43].

The authors of [28] propose a tweakable block cipher named CRAFT. This cipher is claimed as the first cipher level protection against DFA. The underlying approach here is a detective countermeasure which is able to detect the double fault, thanks to an error detecting code used in conjunction with duplication. Also, because of the overlapping nature of error detecting code and the (non-duplicated) cipher, the cost is generally less than what would be for other major ciphers. The idea of using coding theory is previously used in [101], where an architecture capable of detecting and correcting certain fault-induced errors was proposed.

7.3 Infection

Infective countermeasures are proposed as an enhancement to detection. A detection mechanism generally relies on the logical state of only one particular bit (such as the zero flag of a micro-controller). The idea of infection first emerge in the context of public key cryptography, which is later extended to symmetric key. Examples include, [78, 80, 160, 169]. It is noted in [115] that such countermeasures would require randomness⁶. All the infective proposals following [115] use randomness.

Infection based countermeasures introduce a diffusion caused by the faulted intermediate value that spreads further into entire cipher state to avoid explicit detection. Overall, they can be classified into two types. In one type, the two computations (actual and redundant) are allowed to run for full rounds. Then, the XOR between the two computations (Δ) is computed; which is passed into another function, τ , such that $\tau(0) = 0$ and $\tau(\Delta)$ is a random value if $\Delta \neq 0$ (τ uses a hidden random parameter). The output from τ is then used with the actual computation of the cipher (such as, XORed). Therefore, if both outputs are equal, the circuit continues by outputting the result. Examples of this type include [78, 115]. In the other type, introduced in [80], XOR of the actual and the redundant computations is done as they are being computed at each round. If the XOR result is non-zero at some round, then the diffusion of the underlying cipher is used to propagate the

difference through the subsequent rounds, finally making the output unusable for the attacker. A more comprehensive analysis, together with state-of-the art results can be found in [17].

As already mentioned, infective countermeasures do not work against the double faults. Besides, infective countermeasures cannot provide safeguard against collision (Section 5.2.1), ineffective (Section 5.2.3) attacks; as they utilize situations where injection of faults does not alter the output.

Interestingly, quite a few infective countermeasures were broken soon afterwards by standard DFA technique. Nonetheless, to the best of our knowledge, the following three have not been broken by DFA: GF(2^{128}) multiplication proposed in [115] (the lightweight variant of this protection was broken in [24]); modification of [78] proposed in [79, Section 5] (the original proposal in [78] was broken in [19]); and the one in [128, 169]⁷ (see Section 7.6 for non-DFA attacks on this proposal).

It has been shown in [17] that the countermeasure proposed in [169] does not follow the infection paradigm, as it suffers from the one-bit judgment condition similar to detection. A similar claim is made in [72, Section VIII.A].

7.4 Prevention

This type of countermeasure works at the software implementation by inserting dummy instructions, randomization of execution etc. For example, usage of idempotent instruction sequences against an instruction skip attack [123] or *intra-instruction redundancy* [132] fall into this category. These countermeasures can be adopted on top of other fault (such as infection) or side channel (such as masking) countermeasures.

7.5 Re-keying, Tweak and Tweak-in-Plaintext, Masking Plaintext

Re-keying [121] is a protocol level approach; here it is assumed that a relatively smaller portion of the device can be protected, whereas the rest of it is still vulnerable to fault attack. The concept was extended to multi-party set-up in [120]. The basis of re-keying is the *re-keying function*, g ; which generates a different session key K_i^* for each session i with the help of the (fixed) master key K and a random nonce (different for every session); and has a low hardware footprint. Later, this session key is used in an underlying block cipher E with plaintext P_i as: $C_i = E_{K_i^*}(P_i)$. Even if g is not secure cryptographically, as per the authors claim, this scheme is capable of thwarting DFA and side channel attacks. The basic principle is, g guarantees that the effective key is changing at every session, while these attacks require the key to remain fixed for successive sessions.

However, this scheme suffers from a birthday attack, and can only provide security up to the birthday bound on the session key size, as pointed out in [67]. As an improvement, it was later proposed to replace the re-keying function with a tweakable block cipher, with a block counter acting as a tweakable input [68]. This work extended the security of fresh re-keying scheme beyond birthday-bound security against side channel attacks. In a parallel work, it was shown in [131] that, a tweakable block cipher with a random (unknown) tweak can prevent fault attacks.

An approach entitled tweak-in-plaintext was proposed to solve some of the issues with the aforementioned works [15]. By reducing the bandwidth linearly, a sub-exponential safeguard against DFA was achieved, without the need of the synchronization between the communicating parties. One similar concept of masking the plaintext was proposed in [84, Algorithm 1], where the bandwidth was halved. However, in both the cases, decryption circuit cannot be protected against fault attacks (the authors in [15] indeed argue that this is not a serious limitation).

7.6 Attacks on Countermeasures

Several fault attacks specifically target some fault countermeasure. Normally, redundancy based countermeasures can be bypassed by injecting identical faults on the redundant operations. For example, in [129], the authors introduced bias in the fault distribution, which could be exploited to inject same faults in the branches of a time redundancy countermeasure. In [163], identical faults were injected to bypass the hardware redundancy countermeasures. In [45, 87], the authors showed the practical experiments on how to bypass information redundancy countermeasure (encoding approach). Also, recently, in [150], the authors showed how to exploit the redundancy based countermeasure itself to leak some information.

Some of the infective countermeasures were shown to be broken by DFA approach (see Section 7.3). Some non-DFA techniques, such as modifying the round counter or stuck-at fault, were also proposed in [25] against [169]. Also, in [66], it was shown that even with the knowledge of only the correct outputs (the technique is called SIFA, see Section 5.4.1), it is still possible to recover the secret information when the cipher is protected by the aforementioned countermeasure. FIMA model [138] (Section 5.4.3) can be used to break both the detective and the infective countermeasures.

7.7 Specialized Countermeasures against Statistical Ineffective Fault Attack

The countermeasures discussed so far are incapable of thwarting SIFA, in general. Specialized countermeasures are needed for protecting against SIFA. The countermeasures proposed in this regard are listed here.

7.7.1 Repetition Code. The authors in [47] propose an error correction which is based on binary repetition code. Taking majority voting, this countermeasure corrects the fault injection (which can alter at most one bit), and stops the attacker from getting information on whether the fault has occurred or not.

7.7.2 Masking and Repetition Code. A two-phase approach is proposed in [152]. At the first phase, masking is used that protects against faults at the state. At the second phase, attacks on individual sub-operations like SBox are prevented by error correction.

7.7.3 Error Detection through Toffoli Gate and Masking. Based on reversible computing paradigm, Daemen et al. [58] propose an error detection mechanism that targets at most one bit. The non-linear components are designed using Toffoli gates in such a way that a single bit flip would result in a garbage output.

7.7.4 Error Correction. An error correcting code is used by [164] which is able to protect against SIFA. The authors propose a more general code than the repetition code used earlier.

7.7.5 Removing Bias by Duplication. While the other countermeasures rely on non-standard gate like Toffoli or at least triplicate the cost, a recent countermeasure relies on duplication [16]. This way, the authors are able to provide the least expensive SIFA countermeasure. This countermeasure is later extended to protect against the so-called *Fault Template Attack* (FTA, it makes use of one input of an AND gate getting stuck-at to zero, [149]) in [14].

7.8 Automated Application of Countermeasures

Following up on Section 6, there are also multiple works aiming at automated application of fault countermeasures. Compiler-assisted methods are first introduced for side channel attacks [26] and quickly gained popularity in the fault community [29, 137]. This is followed by a formal verification of application of these countermeasures [91]. Automated definition of detection codes for

pre-specified fault models is introduced in [39]. A definition of novel instructions to automatically provide certain resistance to physical attacks is proposed in [92]. Similarly for hardware implementations, it is shown possible to automatically synthesize the countermeasures [70]. Further, an automated approach to cover the sensitive circuit with a glitch detection sensor is proposed in [102].

Apart from that, there are approaches aiming at providing formal definitions of fault attacks and related countermeasures so that these can be further used to detect vulnerabilities automatically and implement fitting protection methods [42, 82].

8 FAULT INJECTION ATTACK COMBINED WITH SIDE CHANNEL ATTACK

Although not a single analysis method on its own, a combined *Fault Injection Attack* (FIA)⁸ + SCA is a category on its own. It has been shown that by using these two attacks at the same time, the attacker can gain a significant advantage over using just one of these alone.

The first proposal in this direction is called *Differential Behavioral Analysis* [140] and combines differential power analysis with a safe-error attack. Later, two combined attacks on AES are proposed, targeting protected implementations [54, 142]. The AES key schedule is another target of the combined attack in [59]. In [130], the authors show that bit permutation-based ciphers are especially vulnerable to such attacks as this type of diffusion allows for easy difference recognition by side channels. The result from [127] reveals that injection of faults can dramatically reduce the effectiveness of SCA countermeasures and leads to a fast key recovery. It is also shown that existing SCA attacks can be directly applied in a purely FI setting, by translating power FI results to generate FI “probability traces” as an analogue to power traces [167]. Combination of SIFA with a profiled power analysis is used in [9].

9 OUTLOOK

Although fault attacks in the symmetric key setting are a very active research field, not much effort have been put to gather various concepts together. This paper aims at filling the recent gap of a compact description of notable works. All major aspects of fault attacks are covered, that includes: models, attack and analysis techniques, automation ideas, and countermeasures. Apart from noting the already presented ideas, we also describe several new viable ways to explore in the future. We notice that sometime the research topics are overlapping, causing uncertainty in proper terminology. Hence, another objective of this work is to streamline the terminologies with classification based on recent results. We believe that this work will be useful to the community as a reference for literature survey.

We list the following broad research directions for the consideration of the community. It is probably a bit early to tell which/how many of the directions will turn out to be viable, still for the time being those seem like promising areas for the development of this area.

- **Combined SCA + FA.** Several works have adopted the combined approach of both SCA and FA [7, 9, 51, 55, 141, 150]. As it has been demonstrated that the combined approach could improve the performance, further investigation might be a possible direction.
- **Combined FA + SCA countermeasure.** As already mentioned in [115], adding randomness is beneficial for protection against FA. Randomness is also the basis of *masking* which is a provably secure countermeasure against SCA [136], and a preferred method in both industry and academia. However, a pure usage of randomness is not sufficient when considering FA, as the attacker can eventually succeed with injecting the intended fault with a high enough number of iterations. On the other hand, there have been proposals for a combined

countermeasure based on *hiding* which use coding theory approaches, such as [38], which can provably protect against certain fault models, but fall short when it comes to SCA – a higher number of traces can always defeat hiding. Therefore, it would be beneficial to find an approach that can provide provable security against both without the need of stacking two methods on top of each other, while keeping a reasonable overhead. If the overhead is not an issue, a usage of multi-party computation protocol based method like CAPA [60] might be an option.

- **New fault analysis methods.** In the past few years we were witnessing the emergence of novel analysis methods, such as SIFA, PFA, FTA, which can (for the most part) bypass the “traditional” countermeasures based on redundancy. As the researchers develop additional protection methods aiming at thwarting these new attacks, it is expected there will be novel analysis methods proposed, looking at loopholes in the new countermeasures. As of now, a few countermeasures utilizing randomness and error correction can be used against SIFA and FTA. We believe the next fault analysis method(s) that can break those would gain attention in the community.
- **Remote fault techniques.** The problem with fault injection techniques is that the relatively precise injection techniques such as voltage glitching, EM pulse, and optical FI, require a direct access to the device. On the other hand, there is Rowhammer [124] which is shown to be capable of disturbing memories remotely, however, the practicality and preciseness of this method is disputable. Therefore, the holy grail in this area is to find an intersection of these two directions – a remote, practical, and precise technique that can disturb ICs.
- **Realization of theoretical fault countermeasures.** The theoretical measures (like non-malleable code [69, Section 1.2]) are claimed to work against the fault attacks, at least to some extent. However, so far there does not seem to be any practical attempt to validate the usefulness of such measures. One may be interested in porting the theoretical measures at the fault countermeasure domain.
- **Cipher level protection against full-DFA.** It is to be noted that DEFAULT (Section 7.1) provides square-root DFA security, and the concept cannot be directly extended to achieve full-DFA security (although the bound can be improved from square-root). Therefore, it remains an open question whether or not it is possible to achieve full-DFA security by cipher construction; if possible then how to construct the cipher/do the security proofs, and what will be the cost (whether the cost will be comparable to cipher duplication).
- **Cipher with native support for a certain fault countermeasure.** One may consider designing new ciphers that will be easier to adopt with certain fault countermeasures. For example, we have seen CRAFT (Section 7.2) has some form of native support for adopting a detection-based DFA countermeasure. This concept can be extended to some other countermeasure (e.g., a cipher where a preexisting SIFA countermeasure is easier to adopt).
