

About INHOPE

INHOPE is a global network of hotlines combatting online child sexual abuse material (CSAM).

INHOPE hotlines receive reports of CSAM from the public. When hotline analysts confirm a report contains illegal material, they send a Notice & Takedown order to the hosting provider. They also send the material to their domestic law enforcement to help with investigations.



INHOPE's technology platform, ICCAM, facilitates the secure exchange of CSAM between 240+ hotline analysts across 50 jurisdictions, so that more illegal content is removed faster. ICCAM also facilitates the transmission of previously unseen material to the INTERPOL database to help victim identification efforts.

2023 Key Takeaways:

- Hotlines received over 1.1 million reports from the public relating to CSAM.
- 785,322 individual reports of CSAM were exchanged via the ICCAM system which is a 25% increase from the previous year.
- 88% of CSAM reports related to content that had never been seen before by hotlines, industry or law enforcement and did not appear on the primary hash lists.
- 83% of CSAM victims were under 13 years of age.

Network Expansion



Funding empowers the Network Expansion team to conduct workshops and roundtables worldwide. In 2023, these initiatives led to the successful establishment of four new hotlines in Argentina, Moldova, Ukraine, and Slovakia. By supporting the dedicated efforts required for such achievements, our partners play a crucial role in enabling country ownership and faster removal of CSAM online.

Capacity Building



Yearly donations directly support the swift and compliant handling of CSAM reports. This financial backing facilitates peer-to-peer exchanges, monthly Q&As, and training sessions on topics such as age assessment and victim identification. These initiatives result in more focused law enforcement investigations, ultimately leading to the rescue of more child victims.

Technology Development



Partnerships fund critical technological advancements, such as ongoing enhancements to our ICCAM system ensuring secure CSAM exchange between hotlines, the development of a law enforcement portal for swift and secure data exchange between hotlines and national agencies, and ambitious hash-matching initiatives.

CASE STUDIES

Meta Grant



Meta's project-based grant strengthened INHOPE's Network Expansion efforts. In 2023, this grant enabled INHOPE to conduct:

- 67 high-level meetings across 19 diverse nations spanning the Middle East, Africa, and Asia.
- Four dynamic roundtables orchestrated in Cameroon, Nigeria, South Africa, and Zimbabwe, uniting law enforcement, government bodies, big tech, and NGOs.
- A ground-breaking achievement: the establishment of Nigeria's new hotline (ACSAI), coupled with comprehensive capacity-building initiatives, including tailored training sessions for local analysts and national law enforcement. These sessions covered critical areas such as content assessment, report management, and staff well-being.

Google

Google Tides Project

- INHOPE, supported by Google.org, is establishing hotlines in countries lacking online CSAM reporting mechanisms, strategically selected based on rising OCSEA production or hosting numbers across regions.
- Google's funding enables intensive collaboration with national organisations, raising awareness among key stakeholders, including the tech industry, law enforcement, and government.
- These funds enable INHOPE to facilitate stakeholder roundtables across the globe, empowering prospective organisations to develop a comprehensive response to CSAM.
- This collective effort has led to the successful establishment of four new hotlines in 2023 alone (Argentina, Moldova, Slovakia, and Ukraine) marking a significant stride in combating online CSAM globally.

- This technological alliance not only enhances the efficiency of our analysts but also streamlines their workflow in confronting harmful and distressing content on a daily basis. Thanks to this innovation, our analysts are able to do their job more effectively.





























