MANAGEMENT AND BUDGET

HIGHLIGHTS OF JULY 31 COUNCIL MEETING.....

FY 1976 agency assessments were discussed. Some questions were raised concerning the substance and formulas used for some of the assessments. These points are being examined. The Council will be advised of the results of this examination.

HIGHLIGHTS OF AUGUST 7 COUNCIL MEETING.....

REMINDERS AND DUE DATES.....

- ... Responses to OP on the proposed Executive and Managerial Training System are OVERDUE.
- ... Submit input for the October OA and OI conference to Mr. Bolduc by AUGUST 22.
- ... The August 14 meeting on the working capital fund has been postponed.
- ... Council recommendations for the OA Executive Development position should be submitted to Sy Pranger by August 14.
- ... By Sept. 2, the Council will receive an accomplishment report and a revised action plan concerning the NFC items furnished the Council on Feb. 6.
- ... Council comments on the payroll cycle should be sent to Dennis Boyd by August 14.

George Knapp, 00, advised the Council that FEA and GSA have developed a proposed multi-year energy conservation program for the government. Agencies can expect a long-term, systematized energy conservation program.

Sy Pranger, OP, and Len Greess, OA, discussed a position in OA which could be an Executive Development position. (See REMINDERS above)

Dennis Boyd, NFC, presented a progress report on action items from last January's NFC conference. (See REMINDERS above)

HOUSE-SENATE CONFEREES REPORT H.R. 4222 EXTENDING CHILD NUTRITION

PROGRAMS.....Since the bill's increased costs exceed the Congressional
Budget Committees' target, it may be sent back to conference when Congress
returns. It also exceeds the President's budget request. (Contact: Bob
Buchanan, OMF, ext. 72327)

CONFERENCE ON USDA APPROPRIATIONS TO FOLLOW RECESS.....Senate floor action was completed on July 25 with the following changes from the Senate committee bill which was summarized in Issue #16:

- -- An additional \$6.6 million was provided for emergency flood rehabilitation work in Montana;
- -- A net increase of \$5.3 million was added to the Child Nutrition appropriation for equipment assistance and State administrative expenses;
- -- \$50 million was added for soil and water loans;
- -- \$2.3 million was added for domestic farm labor grants;
- -- Language was added to ACP which would expand the program from the 1970 practices to "Other farming practices as may be deemed desirable by the county committees."

In terms of total outlays, both the House and Senate bills are very close to the President's budget. The House is about \$7 million below the budget while the Senate is about \$18 million above the budget. (Contact: Steve Dewhurst, OMF, ext. 76176.)

USDA'S PROPOSED PRIVACY ACT REGULATIONS PUBLISHED FOR COMMENT..... They appeared in the Federal Register of August 4. They govern all systems of records maintained by USDA agencies and staff offices, and will take effect on Sept. 27, 1975. Highlights are:

-- An individual will have the right to request access to any records pertaining to him or her. They may also request the records be corrected or amended. If either request is denied, the matter may be appealed.

- -- Medical records may be withheld from the requester but sent to a doctor designated by the individual.
- -- Records may not be disclosed without the written request or written consent of the individual to whom the record pertains.

One of the principal USDA comments was that cooperative agreements should not be covered by this circular. GSA has proposed covering cooperative agreements in the circular with a temporary waiver for USDA programs pending review on a program by program basis to establish appropriate circular coverage.
